Federal Rule of Civil Procedure 45 (c), (d), (e), and (g) (Effective 12/1/13)

(c) Place of Compliance.

(1) For a Trial, Hearing, or Deposition. A subpoena may command a person to attend a trial, hearing, or deposition only as follows:

- (A) within 100 miles of where the person resides, is employed, or regularly transacts business in person; or
- (B) within the state where the person resides, is employed, or regularly transacts business in person, if the person
 - (i) is a party or a party's officer; or
 - (ii) is commanded to attend a trial and would not incur substantial expense.

(2) For Other Discovery. A subpoena may command:

- (A) production of documents, electronically stored information, or tangible things at a place within 100 miles of where the person resides, is employed, or regularly transacts business in person; and
- (B) inspection of premises at the premises to be inspected.

(d) Protecting a Person Subject to a Subpoena; Enforcement.

(1) Avoiding Undue Burden or Expense; Sanctions. A party or attorney responsible for issuing and serving a subpoena must take reasonable steps to avoid imposing undue burden or expense on a person subject to the subpoena. The court for the district where compliance is required must enforce this duty and impose an appropriate sanction—which may include lost earnings and reasonable attorney's fees—on a party or attorney who fails to comply.

(2) Command to Produce Materials or Permit Inspection.

(A) *Appearance Not Required.* A person commanded to produce documents, electronically stored information, or tangible things, or to permit the inspection of premises, need not appear in person at the place of production or inspection unless also commanded to appear for a deposition, hearing, or trial.

(B) *Objections.* A person commanded to produce documents or tangible things or to permit inspection may serve on the party or attorney designated in the subpoena a written objection to inspecting, copying, testing, or sampling any or all of the materials or to inspecting the premises—or to producing electronically stored information in the form or forms requested. The objection must be served before the earlier of the time specified for compliance or 14 days after the subpoena is served. If an objection is made, the following rules apply:

- (i) At any time, on notice to the commanded person, the serving party may move the court for the district where compliance is required for an order compelling production or inspection.
- (ii) These acts may be required only as directed in the order, and the order must protect a person who is neither a party nor a party's officer from significant expense resulting from compliance.

(3) Quashing or Modifying a Subpoena.

(A) *When Required.* On timely motion, the court for the district where compliance is required must quash or modify a subpoena that:

- (i) fails to allow a reasonable time to comply;
- (ii) requires a person to comply beyond the geographical limits specified in Rule 45(c);
- (iii) requires disclosure of privileged or other protected matter, if no exception or waiver applies; or
- (iv) subjects a person to undue burden.

(B) *When Permitted.* To protect a person subject to or affected by a subpoena, the court for the district where compliance is required may, on motion, quash or modify the subpoena if it requires:

- (i) disclosing a trade secret or other confidential research, development, or commercial information; or

- (ii) disclosing an unretained expert's opinion or information that does not describe specific occurrences in dispute and results from the expert's study that was not requested by a party.

(C) *Specifying Conditions as an Alternative.* In the circumstances described in Rule 45(d)(3)(B), the court may, instead of quashing or modifying a subpoena, order appearance or production under specified conditions if the serving party:

- (i) shows a substantial need for the testimony or material that cannot be otherwise met without undue hardship; and
- (ii) ensures that the subpoenaed person will be reasonably compensated.

(e) Duties in Responding to a Subpoena.

(1) Producing Documents or Electronically Stored Information. These procedures apply to producing documents or electronically stored information:

(A) *Documents.* A person responding to a subpoena to produce documents must produce them as they are kept in the ordinary course of business or must organize and label them to correspond to the categories in the demand.

(B) *Form for Producing Electronically Stored Information Not Specified.* If a subpoena does not specify a form for producing electronically stored information, the person responding must produce it in a form or forms in which it is ordinarily maintained or in a reasonably usable form or forms.

(C) *Electronically Stored Information Produced in Only One Form.* The person responding need not produce the same electronically stored information in more than one form.

(D) *Inaccessible Electronically Stored Information.* The person responding need not provide discovery of electronically stored information from sources that the person identifies as not reasonably accessible because of undue burden or cost. On motion to compel discovery or for a protective order, the person responding must show that the information is not reasonably accessible because of undue burden or cost. If that showing is made, the court may nonetheless order discovery from such sources if the requesting party shows good cause, considering the limitations of Rule 26(b)(2)(C). The court may specify conditions for the discovery.

(2) Claiming Privilege or Protection.

(A) *Information Withheld.* A person withholding subpoenaed information under a claim that it is privileged or subject to protection as trial-preparation material must:

- (i) expressly make the claim; and
- (ii) describe the nature of the withheld documents, communications, or tangible things in a manner that, without revealing information itself privileged or protected, will enable the parties to assess the claim.

(B) *Information Produced.* If information produced in response to a subpoena is subject to a claim of privilege or of protection as trial-preparation material, the person making the claim may notify any party that received the information of the claim and the basis for it. After being notified, a party must promptly return, sequester, or destroy the specified information and any copies it has; must not use or disclose the information until the claim is resolved; must take reasonable steps to retrieve the information if the party disclosed it before being notified; and may promptly present the information under seal to the court for the district where compliance is required for a determination of the claim. The person who produced the information must preserve the information until the claim is resolved.

(g) Contempt.

The court for the district where compliance is required—and also, after a motion is transferred, the issuing court—may hold in contempt a person who, having been served, fails without adequate excuse to obey the subpoena or an order related to it.

2 **DEFINITIONS**

3 1. Notwithstanding any definition below, the terms used in these Requests
4 shall be construed and defined in accordance with and to have the broadest meaning
5 permitted under the Federal Rules of Civil Procedure, wherever applicable. Any terms
6 not defined shall be given their ordinary meaning.

7 2. Words or terms not specifically defined herein have the meaning commonly
8 understood, and no definition or example is intended as exclusive.

9 3. Words or terms used herein, and all Definitions and Instructions pertinent
10 thereto, have the same intent and meaning regardless of whether the word or term are
11 depicted in lower-case or upper-case letters.

12 4. “Communication” or “Communications” means any Document that
13 comprises, embodies, memorializes, reflects, or refers to any transmission of information
14 from one Person to another, including, without limitation, any correspondence, contact,
15 discussion, or written, electronic, or oral exchange. This includes relevant hard-copy
16 files, correspondence files, appropriate locations on hard drives and shared drives, emails,
17 text messages or other direct messaging systems (such as iMessage, WhatsApp, Signal,
18 or Twitter direct messages), voicemail messages, instant messaging systems such as Lync
19 or ICQ, and shared messaging systems such as Slack. Each Request that seeks
20 information relating in any way to Communications to, from, or within a business or
21 corporate entity is hereby designated to mean, and should be construed to include, all
22 Communications by and between any representatives, employees, attorneys, accountants,
23 auditors, investigators, and/or agents of the business or corporate entity, and/or any other
24 Persons acting on that entity’s behalf or under its direction or control. Any reference to
25 “All Communications” refers to all Documents related to Communications.

26 5. “Document(s)” shall be construed in the broadest sense to mean any and all
27 written, typed, recorded, graphic, printed, or audio material of any kind that are in Your
28 possession, custody, or control. This includes electronic records, audiotapes or

1 recordings, videotapes, photographs, papers (whether handwritten, printed, or typed),
2 memoranda, letters and other correspondence, emails, notes, agendas, notebook entries,
3 bulletins, graphs, charts, maps, drawings, surveys, data, summaries, telegrams, calendar
4 entries, diaries, spreadsheets, graphics and presentation documents, images, text files,
5 transaction logs, reports of any kind, estimates, receipts, invoices, checks, bids,
6 proposals, licenses, reports to or communications with government entities, financial
7 statements, ledger entries, microfilm, microfiche, computer printouts, computer files,
8 cards, disks, flash drives, facsimiles, telephone messages, voice mail messages and
9 transcripts, notes, minutes of any meetings, telephone conversations or discussion, and
10 any other sources of electronically or magnetically maintained information, regardless of
11 who prepared or created the document. This also includes any attachments to those
12 records or other materials enclosed with those records when they were previously
13 transmitted. A draft or non-identical copy is a separate document within the meaning of
14 this term. To the extent that an email is responsive to this Request, this Request includes
15 all prior messages sent or received in that email chain, as well as any attachments to the
16 email and/or to prior messages sent or received in that email chain. This includes records
17 regarding agency business contained in files, email accounts, or devices in the personal
18 custody of Defendant or its employees, including personal email accounts or text
19 messages.

20 6. “Permanent Early Voting List” means the list of voters to receive an early
21 ballot maintained by each county recorder pursuant to A.R.S. § 16-544. All references to
22 the Permanent Early Voting List include the “Active Early Voting List” created by SB
23 1485’s amendments to A.R.S. § 16-544.

24 7. “Person” or “Persons” means any individual, general or limited partnership,
25 joint stock company, unincorporated association or society, municipal or other
26 corporation, incorporated association, limited liability partnership or company, the State
27 of Arizona or an agency or subdivision thereof, a court, and any governmental entity or
28 official in or outside the State of Arizona.

1 8. "SB 1485" means Senate Bill 1485, which was passed by the Arizona
2 Legislature on or about May 11, 2021, and signed into law by Governor Doug Ducey on
3 or about May 11, 2021, as well as any prior versions of SB 1485 and any predecessor or
4 related bills.

5 9. "SB 1003" means Senate Bill 1003, which was passed by the Arizona
6 Legislature on or about May 7, 2021, and signed into law by Governor Doug Ducey on or
7 about May 11, 2021, as well as any prior versions of SB 1003 and any predecessor or
8 related bills.

9 10. "You" and "Your" mean and refer, collectively and individually, to the
10 Subpoena recipient.

11 11. The following rules of construction apply to all Requests:

12 a. The terms "all" and "any" shall each be construed as encompassing
13 any and all;

14 b. All uses of the word "each" include "every" (and vice versa);

15 c. The connective terms "and" and "or" shall be construed either
16 disjunctively or conjunctively as necessary to bring within the scope of the Requests all
17 responses that might otherwise be construed to be outside of its scope;

18 d. Use of the singular form of any word includes the plural (and vice
19 versa);

20 e. The term "including" shall be construed without limitation;

21 f. The use of a verb in any tense encompasses the use of the verb in all
22 tenses;

23 g. References to employees, staff, members, officers, directors, agents,
24 or representatives includes both current and former employees, staff, members, officers,
25 directors, agents, or representatives; and

26 h. References to any entity includes all of that entity's employees, staff,
27 members, officers, directors, agents, or representatives.

28 **INSTRUCTIONS**

1 1. These Requests call for the production of all responsive Documents that are
2 within Your possession, custody, or control. A Document is in Your “possession,
3 custody, or control” if it is in Your physical possession, or if, upon request, You are
4 entitled to obtain possession of the Document or a copy thereof from another person or
5 entity that has physical possession of the Document.

6 2. Each Request shall be construed according to its most inclusive meaning so
7 that if information or a document is responsive to any reasonable interpretation of the
8 request, the information or document is responsive.

9 3. Each Request shall be construed independently, and no Request shall be
10 viewed as limiting the scope of any other Request.

11 4. If You object to a Request, state whether Documents are being withheld
12 from inspection and production on the basis of such objection, or whether inspection and
13 production of the responsive Documents will occur notwithstanding such objection.

14 5. If You object to a particular Request and refuse the answer that part,
15 identify that portion of the request to which You object and respond to the portion of that
16 request not subject to that objection.

17 6. If You object to the scope or time period of a Request and refuse to respond
18 for that scope or time period, please state Your objection and respond to the Request for
19 the scope or time period You believe is appropriate.

20 7. If You object to any Request as vague or unclear, assume a reasonable
21 meaning, state what the assumed meaning is, and respond to the Request according to the
22 assumed meaning.

23 8. If You object to any Request as overbroad, provide a response that narrows
24 the Request in a way that eliminates the purported over-breadth, state the extent to which
25 Your response has narrowed the Request, and respond to the narrowed Request.

26 9. If any Document or category of Documents is not produced in full, state
27 with particularity the reason or reasons it is not being produced in full, and describe, to
28

1 the best of Your knowledge, information, and belief, and with as much particularity as
2 possible, the Document or portions of the Document that are not being produced.

3 10. If You are unable to respond to any of the Requests fully and completely,
4 after exercising due diligence to obtain the information necessary to provide a full and
5 complete response, so state, and answer each such Request to the fullest extent possible,
6 specifying the extent of Your knowledge and Your inability to answer the remainder, and
7 setting forth whatever information or knowledge You may have concerning the
8 unanswered portions thereof and efforts You made to obtain the requested information. If
9 You have no information responsive to a Request, then state that to be the case.

10 11. For any Document or category of Documents that was, but no longer is, in
11 Your possession, custody, or control, describe each such Document as completely as
12 possible and provide the following information:

13 a. The reason the Document is no longer in Your possession, custody,
14 or control;

15 b. The person or entity, if any, who has possession, custody, or control
16 or, if unknown, so state; and

17 c. If the Document was destroyed or otherwise disposed of, state:

18 d. The manner of disposal (i.e. destruction, loss, discarding, or other
19 means of disposal);

20 e. The date of disposal;

21 f. The reason for disposal;

22 g. The person authorizing disposal;

23 h. The person disposing of the Document; and

24 i. The name and address of the most recent custodian of the Document.

25 12. If You withhold any Document, or portion of a Document, on grounds that
26 it is protected from discovery by the attorney-client privilege, work-product doctrine, or
27 other privilege or immunity from discovery, set forth, for each Document or portion of a
28 Document withheld:

- 1 a. The place, approximate date, and manner of recording, creating, or
2 otherwise preparing the Document;
- 3 b. The names and organization position, if any, of each author, sender,
4 and recipient of the Document;
- 5 c. A general description of the subject matter of the Document;
- 6 d. If withheld in whole, a statement of why it is not reasonable to
7 segregate portions of the record for release;
- 8 e. The specific factual and legal basis of any claim of privilege, in
9 sufficient detail for Plaintiffs to assess the applicability of the privilege claimed; and
- 10 f. If work-product is asserted, the proceeding for which the Document
11 was created.

12 13. These Requests impose a continuing obligation subsequent to this initial
13 production to timely supplement Your response or production if You determine that Your
14 response or production is incomplete or incorrect Document was created.

15 14. The collection and production of Documents shall be performed in a
16 manner that ensures that the source of each Document may be determined, if necessary.

17 15. Documents attached to each other shall not be separated, and the parent-
18 child relationship of documents must be kept intact.

19 16. All Documents requested must be produced (along with any draft(s)
20 thereof) in their entirety, without abbreviation, expurgation, or redaction.

21 17. If a Document has been prepared in several copies that are not identical, or
22 if additional copies have been made that are no longer identical, or if original identical
23 copies are longer identical by reason of subsequent notation or other modification of any
24 kind whatsoever, including, but not limited to, notations on the front or back of pages
25 thereto, each non-identical copy is a separate Document and must be produced.

26 18. When any part of a Document is responsive to any individual request, You
27 must produce the Document in its entirety, including, but not limited to, attachments,
28 cover memoranda, exhibits, and appendices. In the event that some portions of Requests

1 are properly exempt from disclosure or protected from discovery, Defendant should
2 disclose any reasonably segregable non-exempt portions of the requested records.

3 19. The parties shall meet and confer about an appropriate ESI protocol.
4 Notwithstanding, all documents are to be produced in electronic form.
