Example: "I give and bequeath [specific amount or percentage] to the Arizona Free Enterprise Club, an organization located at 1835 E. Elliot Rd. Suite #102, Tempe, AZ 85284 under Federal tax identification number 20-2423383, for its general use and purposes."
